

Tips to Avoid Rental Scams and Secure a Home

It is necessary to have some basic knowledge about scammers and their techniques in order to successfully secure a safe place to rent. In this document, we have provided you with a few tips and links to useful resources. We encourage you to read through the resources before booking your accommodation, so that you can protect yourself and your money.

The list below will provide a few tips on how to avoid housing scams:

- Verify that the property exists before making any payments. Use Google maps or other mapping tools to verify the location of the property and if it exists. If you know someone who lives near rental place, you can ask them to verify the apartment for you as well.
- Check reviews of the property. Most property rental websites will have feedback from previous guests on their stay. Checking those reviews will help you get a better idea on the place, you are planning to rent.
- Compare rental property prices: who is responsible for what? Are utilities part of the arrangement? If so, which ones, and will they be automatically set up? Additionally, is the space fully furnished, partially furnished, or not furnished at all?
- Be wary of deals that seem too good to be true.
- Never send money if you don't feel that the listing is legitimate.
- When doing an image search of the pictures featured in an ad, you can see whether these pictures have already been posted on other sites. Scammers sometimes use pictures from other ads. Pictures that look too professional could be indicative of fraud.

If you are planning on finding an accommodation outside of campus for your internship, please be wary of rental scams. Rental scams tend to rise in the summer.

As you will be arriving between the month of May to July, you need to be cautious of types of properties that are listed as some of them could be fraudulent. The rental scammers are taking photos of properties that are already online, on housing sites and using those photos to create fake rentals ad. The tips that were provided above can help you determine if a property is real or not.

These are a few examples of websites that can help you find a temporary accommodation near your university:


Airbnb: https://www.airbnb.ca/



RENTING IN CANADA: THINGS TO KEEP IN MIND

Your choice of house or apartment will probably depend on how much you can afford to pay. Finding affordable housing in Canada can be difficult when all of Canada is going through a housing crisis. Whether you're thinking of living in on-campus housing or renting an off-campus apartment, you'll face similar challenges.

Here are few things you can do to before renting:

- Get familiar with the GRI payment schedule.
 - You'll be able to set a budget based on when you are supposed to receive funding
- Set a budget:
 - Make an estimate of your monthly or weekly expenses, i.e.: food, clothing, daily expenses, unforeseen expenses... from there you will be able to determine if you can pay your rent or not
- Look for a place that fits your budget
 - Do not settle for the 1St temporary housing found. Compare the prices of different housing options
- Be frugal: consider cooking your meals instead of ordering food
- Get a roommate: if there is a person that you can trust and wouldn't mind living with during your internship, you might want to consider a roommate to reduce your expenses

WHAT TO DO IF YOU DO GET SCAMMED

Avoiding scams is better than trying to recover what was lost. But in case you do get scammed here are some things we recommend doing:

- Contact the local police service
 - They might be able to find the scammer and possibly return the money you have lost.
- Get in touch with your bank and report the scam. Most banks can stop fraudulent transactions and can sometimes help you recover the funds. If you did send money overseas through a third party such as Western Union, those vendors' customer service departments may be able to stop the transfer:
 - **Western Union**
 - Paypal Complaint Procedure
 - Remitly: complaint or report an error
